- There is insufficient detail on the community benefit which should be detailed in conditions set as part of any consent. The promises in the application are too vague and PCC would like to see these firmed up and to include, but not be limited to, footpath improvements and safe public amenity access to the areas around the quarry; and education resources.
- PCC would like more information on use of the site after the final restoration and confirmation that the site will be used for community benefit after extraction stops.
- PCC welcomes working with the quarry on these issues.
