3. Public and Press session

M Colley & A Smith were in attendance & commented upon:

- The decision to relocate the Pentyrch Surgery & its impact on residents, particularly the elderly without their own means of transport
- Welsh Government policy to reduce reliance on vehicles
- Attempts to engage with Cardiff & Vale Health Board
- The need to ensure Cardiff & Vale Health Board meet all the specified planning conditions

4. Proposed Relocation of Pentyrch Surgery

Mark Drakeford (MS) commented upon:

- The relocation decision had been made & the process was now exhausted
- The focus should be upon ensuring the new surgery is accessible to all members of the community
- The Minister has been asked to look again at the decision making process
- Continuing a dialogue with Cardiff & Vale Health Board on the transport issue & being prepared to share information with PCC

Mark Drakeford was thanked for his attendance & is to be invited to a meeting in the Autumn.

5. Approved the Minutes of the Meeting held on 19th June 2023 together with the following additions from Cllr Krip:

Dynefor Gardening Association - Cllr Krip expressed her disappointment at Council's decision in light of the current cost of living crisis affecting all residents.

Sale of land at Cefn Bychan - Cllr Krip objected to the sale.

Pentyrch Primary School – Cllr McGrath attended in place of Cllr Krip

- 6. Approved the Minutes of the Staffing Committee held on 3rd July 2023
- 7. Approved the Minutes of the Planning Committee held on 5th July 2023

- 8. Approved the Minutes of the Finance Committee held on the 10th July 2023 & agreed that the decision to accept a quotation for tree works be delegated to the Finance Committee
- 9. Request to sell PCC land at Cefn Bychan

It was agreed to sell the land shown on the attached plan subject to the following conditions:

- The banking below the rear gardens of the adjoining properties be reinforced to a level to the base of the rear fences.
- The current plan shows a small gate from the northwest of the plot onto PCC retained land & this is to be removed.
- The Council's Solicitor be asked to advise on the
 - appointment of a professional valuer
 - whether an abortive fees agreement should be required from the purchaser
- The purchaser will pay:

the cost of valuing the land, which will substantially enhance the property all legal costs incurred by PCC the valuation price of the land

- The sale agreement to contain a clause that PCC will not be liable for the existing condition of the land and that the purchasers will agree to not make any claim against PCC in relation to the condition of the land, including matters such as invasive species e.g., Japanese Knotweed, and also in relation to ground conditions etc.
- The boundary wall, the side facing away from the property, not be purely of block construction & is to be subject to agreement with PCC. The exterior finish to the new boundary wall to be specified and agreed with PCC and the work completed in a timely manner
- Prior to any exchange of contracts, the council will approve the final agreement

Cllr Krip objected to the sale.

- 10. Approved the Minutes of the Business Plan Working Group meeting held on the 21st June 2023.
- 11. Noted that all benches in the ownership of PCC will be inspected by the end of July.
- 12. Agreed the Annual Report for 22/23
- 13. Agreed to invite the community to nominate residents / groups for recognition at the Civic Reception in September 2023.
