4. Approved the Minutes of the Meeting held on 25th September 2023.

5. Approved the Minutes of the Staffing Committee held on 2cd October 2023 and agreed the re-evaluation of the posts of Community Maintenance Officer & Assistant Community Maintenance Officer.

6. Approved the Minutes of the Planning Committee held on 4th October 2023.

No 23/02169/DOC - Creigiau Quarry Application:

The Planning Committee had invited CRC to comment & the agreed response to CCC was:

The proposal is an improvement to the access to the Quarry which will separate the traffic flow to Creigiau Recreation Ground & the Quarry. Vehicle & pedestrian safety will be improved.

As little vegetation as possible should be removed with the remainder cut to create a hedge.

Creigiau Recreation Charity should be consulted on Signage.

It is believed the Underwater Pipe Assumed Position is incorrect - the pipe carries the stream under the access road and discharges on the other side of Heol Pant y Gored, west of proposed signage.

It is not clear what is proposed in relation to access to the Quarry:

If "SINGLE WAY" where will entering & exiting traffic be held?

If "TWO WAY" is there sufficient space for these vehicles?
