- 5. Approved the Minutes of the Planning Committee held on 1st November 2023. Clerk to request info from St Fagans CC
- 6. Approved the Minutes of the Finance Committee held on the 15<sup>th</sup> November 2023 and agreed the following recommendations:

# 9. Meeting of the Transport Committee on 20th November 2023

The meeting was not quorate & an informal discussion was held with representatives of PSOS on the Health Board Invitation to join the Pentyrch & Surrounding Area Branch Surgery Project - Transport Task & Finish Group, first meeting 28<sup>th</sup> November 2023.

It is anticipated the task & finish group will meet over a period of 6 months & initially will focus on a residents survey.

There was agreement that the process for collecting & analysing survey responses needs to be clear & transparent

Papers for the meeting on the 28<sup>th</sup> November are yet to be received & a further meeting is to be arranged with PSOS to discuss the meeting papers.

Council agreed that Cllr's McGrath & Krip will represent the Community Council, & if either is unavailable Cllr Yarrow will attend.

There followed a discussion on the stakeholder feedback report on options for Cardiff's Transport Network. (deadline for comments – 23/11/23)

Council agreed that:

- The report lacks detail
- Insufficient consideration is being given to outlying communities who have no option but to rely on transport by car
- An integrated transport strategy is needed to ensure outlying communities can access public transport & utilise a network which is available to other residents of Cardiff
- Specific proposals need to be developed to ensure outlying communities are connected to the transport network
