G Williams, South Wales Police D Mills, Cardiff Standards & Ethics Committee Representative of PSOS

4. Invitation to Attend Council - Go Safe

Cllr McGrath explained the invitation was due to increased concerns within the community about the volume & speed of traffic.

- G Williams of South Wales Police commented upon:
- The deployment of camera vans is determined by the number of speed related accidents, volume of traffic & community factors e.g. location of a school
- The frequency of deployment is determined by the number of offences
- Use of camera vans, traffic counters & lamppost detection boxes to gather information on vehicle speeds
- Locations which do not meet the criteria to become a designated Go Safe location are referred to the Neighbourhood Policing Team who may work with community speed watch volunteers
- Go Safe enforcement action is focused upon areas without traffic calming
- Heol Pentre is a designated enforcement location.
- Go Safe do not focus upon parking on the pavement but where it is creating traffic hazard video evidence can be uploaded to Operation Snap

PCC is to consider drafting further briefing documents identifying PCC transport concerns such as parking, speeding, pedestrian crossings.

- 10. Deferred grant application from Hilltop Theatre a grant of £250 was agreed.

15. Agreed the terms of reference for the Transport Work Group, with the addition:

To seek expert advice as required to make recommendations.

16. Agreed the terms of reference for the Friends of the Garth Group.

It was agreed to make arrangements for the first meeting of the Group.

17. Installation of Wifi at Pentyrch Village Hall

It was agreed to provide funding of £1426 plus VAT for the installation of Wi-Fi 6 faster, being the set-up cost plus the Wifi maintenance fee for 12 months.

The Council is prepared to fund the ongoing monthly licence fee of £49.81 plus VAT if the Village Hall will waive ongoing rental charges for use of the meeting room for the monthly meetings of Council.

18. Plans to improve access and restore nature in the North Cardiff Woodlands.

L Penny provided an overview of the project & commented upon:

- The partnership between the Wildlife Trust, Cardiff Council & NRW
- The time spent bringing stakeholders together
- The desire to encompass the Garth Mountain within the project
- The aim to restore the natural environment & provide open access for recreational users, particularly mountain bikers
- The bid to be made to the Heritage Lottery
