Meeting of Pentyrch Community Council held at 6.30 on the 15th July 2024 at Pentyrch Village Hall & online via Google Meet.

MINUTES

2. No declarations of interest

3. Public and Press session

Mr Waite & Mr Paul, residents of Gwaelod , spoke about the problems caused by campers in the Coed y Ceiliog woods . The litter, glass & other debris being left in the woods was causing both environmental damage a risk to other users of the woods.

It was agreed that PCC would:

- Investigate ownership of the woods
- Investigate the extent to which use of the woods was being managed

The residents are to provide information on the problem sites.

Mr Waite also spoke about the parking problems in River Glade which were being caused by users of Taff's Well Station. The extent of the problem was posing a risk to residents due to the reduced highway visibility.

Mr Waite is to provide further information

The new Chair of Gwaelod Rangers spoke about the challenges facing the club in relation to the pitch & changing rooms and the desire to work closely with the community. The Clerk is to seek further information.

Mr Smith, PSOS, attended the meeting to listen to PCC discussions about the work of the Transport Group.

8. Approved the Minutes of the Finance Committee held on the 10th July 2024 & agreed the following recommendations:

- Grant payment to CRC of £5,000
- Payment to Mence & Clark of £2,400
- The costs of installing Wifi at Pentyrch Village Hall & the purchase of Camera / Projector for meetings (£ 2118) be funded from the Community Support Fund Earmarked Reserve.
- Cllr Marshall be appointed as an authorised signatory for both the bank & investment accounts held by PCC.

It was also agreed that it was far more appropriate to present Hazel Davies with flowers at the Civic Reception, rather than a voucher.

The Letter is also to be sent to the Transport Minister.

- Change in the frequency of the 122 Bus Service

It was agreed that the information should be shared on Facebook & included in the Community Link, with comments invited.
